



REGULATION NUMBER 40

A regulation establishing fees for the Public Swimming Pool/Public Spa/Public/Special Use Pool, Recreational Vehicle Park/Recreation Camp/Combined Park-Camp/Temporary Park-Camp, Resident Camp, Food Safety, Private Water System, Tattoo/Body Piercing, Building Review, and Infectious Waste environmental health programs in the health district.

BE IT ENACTED by the Logan County General Health District Board of Health, State of Ohio, a majority of the members concurring:

SECTION 1

Pursuant to sections 3709.20 and 3709.21 of the Ohio Revised Code the following annual license fees are hereby adopted and established:

1.1 Operations of public swimming pools, public spas, or public special use pools shall be charged the license fee as follows:

1. Public Swimming pool (which by definition includes public spas and special use pools) \$330.00 + State Fee

1.2 Operators of a recreational vehicle park, recreation camp, or combined park-camp shall be charged a license fee according to the following categories:

1. 50 or less sites \$110.00 + State Fee
2. More than 50 sites * \$1.50

1.3 Operators of a temporary park-camp as defined under section 3729.01 "V" of the Ohio Revised Code, shall be charged a local license fee, per event and be valid for a period of no more than 7 consecutive days, according to the following categories:

1. 50 or less sites \$75.00
2. More than 50 sites * \$1.50

*Note: These parks, camps, park-camps and temporary park/camps shall be charged the fee determined for 50 sites or less PLUS an additional amount for each individual site in excess of 50.

1.4 Resident camp late fee for when payment is not received by the day on which payment is due: 25% of Local Fee

1.5 Operators of a food facility shall be charged a license fee according to the following categories:

1.6 Persons seeking to work on a Private Water System (PWS) shall be charged accordingly:

1. New permit: single family dwelling \$170.00 + ODNR Fee + State Fee
2. New permit: non-single family dwelling \$200.00 + ODNR Fee + State Fee
3. Test well: single family dwelling \$100.00
4. Test well: non-single family dwelling \$120.00
5. Alteration: single family dwelling \$100.00
6. Alteration: non-single family dwelling \$120.00
7. Installation and decommissioning of a temporary hauled water storage tank for a specific time period in a time limited emergency condition. \$100.00
8. Reinspection fee (no access/high chlorine) \$25.00 + Lab Fee + State Fee
9. Water hauler vehicle inspection (conducted under paragraph (C) of OAC 3701-28-18) \$25.00
10. Penalty fee: An amount to be added to the applicable fees when Board of Health determines installation or alteration has commenced prior to a permit or registration being issued. 25% of Local Fee Portion

NOTE: This additional fee shall not be charged for an emergency water well alteration or installation if received within the time limits allowed.

1.6 (cont...)

11. Private water sample fee (bacteriological) \$40.00

Note: The fee for water sample collection and bacteriological testing shall be waived by the Board of Health in cases where a licensed physician's prescription is received requesting a patient's private water system be tested for the presence of bacteriological contamination as part of an illness investigation.

12. Water sample delivered by the public water supply operator/agent or a licensed and bonded home inspector \$25.00
13. Real estate water sample (initial) \$60.00
14. Sealing: single family dwelling \$15.00
15. Sealing: non-single family dwelling \$15.00
16. Variance review by Board of Health \$50.00
17. Penalty fee for work done prior to obtaining a PWS permit. 25% of Local Fee Portion

- 1.7 Establishments offering tattooing and/or body piercing services in the health district shall be charged accordingly:

1. Initial approval, annual renewal approval \$300.00
2. Time-limited or special event approval \$75.00
3. Late fee Fee + 25%

- 1.8 Building review \$25.00
- Building site visit \$75.00

- 1.9 Persons bringing infectious waste sharps containers to the health district for disposal shall be charged a per container handling fee according to the following categories:

- Businesses (medical offices, veterinary clinics, home health agencies, etc.) \$ 4.00
- General public \$ 4.00
- Health district staff as part of district duties No Fee

- 2.0 License/permit duplication fee \$32.00

SECTION II

This amended regulation is of an emergency nature necessary for the preservation of the public health and safety. Fee changes imposed by mandate of the Ohio Public Health Council have increased the revenue required to certify issued licenses to the Ohio Department of Health.

This amended regulation was passed and adopted by the Board of Health of the Logan County General Health District on this 3rd day of November, 1993, and shall be in force and take effect on November 3, 1993.
