


Ohio: 1,023,291 Total | 866,487 Confirmed and 156,804 Probable | Deaths: 18,739

Logan County: 2,488 Confirmed + 1,190 Probable = 3,678 Total Cases. Of those 3,678 cases, 3,558 are presumed

recovered\*. | Deaths: 76 | Active Cases: 120

\*Presumed Recovered is defined as cases with a symptom onset date ≥21 days prior who are not deceased.





### LIAISON:

- Unified Command (EMA, MRH & LCHD) continues to meet on a weekly basis.
- LCHD staff meets with school administrators to provide guidance on a weekly and as-needed basis.
- Continue to attend weekly calls with Governor DeWine and ODH to understand new orders and guidance, as well as provide them insight to local operations.

## LOGISTICS:

- Continued testing carbon dioxide levels, promoting fresh air exchange and indoor air quality around Logan County.
- Continued prioritized contact tracing and using automated one-calls to notify positive cases of test results and isolation & contact tracing instructions.

#### ACTIONS COMPLETED SINCE LAST SITUATIONAL REPORT:

- Continue receiving COVID-19 Vaccine with an increased weekly allotment (now approximately 960 doses per week).
   Continue distribution of vaccine doses based on ODH's Phased Vaccine Distribution Plan (dropping from age 70+ to age 16+ throughout the month of March), via scheduled clinics at LCHD office. LCHD primarily receives the Pfizer vaccine but has occasionally received allotments of Moderna or Janssen. - Continued vaccination clinics at LCHD as well as holding a drive-through clinic at the Logan County Fairgrounds on March 9, 2021. This clinic was by appointment only and with the help of volunteers and partner agencies, 337 individuals were provided their first dose of Pfizer COVID-19 Vaccine in one day.
- Worked with Logan County EMA and Ohio Northern University to schedule four mobile, Janssen Vaccine Clinics around the
  county in Quincy, West Liberty, Belle Center and Zanesfield through April and May of 2021. Clinic dates and times vary.

- Began coordination of COVID-19 vaccination clinics with the Ohio National Guard and Area on Aging. These clinics will be serving age-based housing units in West Liberty and Russells Point.
- Continued monitoring of local and regional hospital bed situation as well as regional hospital census data.
- Continued receiving contact tracing from ODH, & contracted with ODH to receive two staff nurses for vaccine distribution.
- Environmental Health staff continues to assist community planners to make indoor events as safe as possible.

# **STATE INFORMATION:**

- Logan County moved to "orange" and dropped the "high incidence" indicator on the Ohio Public Health Advisory System.
- ODH discontinued issuing a travel advisory for those entering Ohio after traveling to states reporting positive testing rates
  of 15% or higher.
