#### LIAISON:

- Unified Command (EMA, MRH & LCHD) continues to meet on a weekly basis.
- LCHD staff meets with school administrators to provide guidance on a weekly and as-needed basis.
- Continue to attend weekly calls with Governor DeWine and ODH to understand new orders and guidance, as well as provide them insight to local operations.

#### LOGISTICS:

- Continued testing carbon dioxide levels, promoting fresh air exchange and indoor air quality around Logan County.
- Transitioned prioritized contact tracing with PCG (originally ODH).

#### ACTIONS COMPLETED SINCE LAST SITUATIONAL REPORT:

- Continue receiving COVID-19 Vaccine (approximately 960 doses per week, typically Pfizer). Continue distribution of vaccine doses to anyone age 16+ via scheduled clinics at LCHD office. LCHD also began offering in-vehicle and in-home COVID-19 vaccinations. Appointments are still being scheduled through ODH's scheduling system: <https://gettheshot.coronavirus.ohio.gov/>.
- Held a drive-through clinic at the Logan County Fairgrounds on April 6, 2021. This clinic was by appointment only and with the help of many volunteers and partner agencies, nearly 800 individuals were provided their second dose of Pfizer COVID-19 Vaccine in one day.
- Worked with Logan County EMA and Ohio Northern University to hold mobile vaccine clinics around the county including locations in Quincy, West Liberty, Belle Center and Zanesfield through April and May of 2021. Clinic dates and times vary. Visit <https://gettheshot.coronavirus.ohio.gov/> to schedule an appointment at any of these clinic locations. ONU's Mobile clinics offer either Janssen or Moderna vaccinations.
- Held COVID-19 Vaccination clinics in coordination with Ohio National Guard and Area on Aging. These clinics served age-based housing units in West Liberty and Russells Point.
- Continued monitoring of local and regional hospital bed situation as well as regional hospital census data.
- Continued receiving contact tracing assistance from ODH and hired two nurses for vaccine distribution through ODH contract.
- Environmental Health staff continues to assist community planners to make indoor events as safe as possible.

- Continued providing additional programs and services including vital statistics (birth & death certificates), WIC, food inspections, immunizations (limited and by appointment only), TB Testing (by appointment only), Narcan distribution, newborn visits (via phone) and CMH program.
