

COVID-19 Situational Report

As of 5/31/2021, 2:00 PM:

Ohio: 1,102,843 Total | 923,113 Confirmed and 179,730 Probable | Deaths: 19,923

Logan County: 2,589 Confirmed + 1,274 Probable = 3,863 Total Cases. Of those 3,863 cases, 3,750 are

presumed recovered*. | Deaths: 76

*Presumed Recovered is defined as cases with a symptom onset date ≥21 days prior who are not deceased.

LIAISON:

- Unified Command (EMA, MRH & LCHD) now meets every other week.
- Meetings with school administrators will be on an as-needed basis until late July/early August for return to school plans.
- Continue to attend weekly calls with Governor DeWine and ODH to understand the changes to orders and guidance, as well as provide insight to local operations.

LOGISTICS:

- Continued testing carbon dioxide levels, promoting fresh air exchange and indoor air quality around Logan County.
- Transitioned prioritized contact tracing with PCG (originally ODH).

ACTIONS COMPLETED SINCE LAST SITUATIONAL REPORT:

- LCHD is now able to order vaccine as needed and is providing to Ohioans age 12+ (Pfizer only). LCHD continues walk-in COVID-19 vaccination hours Monday and Wednesday from 9:00 AM-12:00 Noon and Tuesdays from 9:00 AM 12:00 Noon and 1:00 PM 3:00 PM. Appointments are still being scheduled through ODH's scheduling system in addition to walk-in hours: https://gettheshot.coronavirus.ohio.gov/.
- Continued COVID-19 vaccinations for homebound individuals as well as small clinics at businesses/groups in Logan County.

- Final vaccination clinics were held around the county with Logan County EMA and Ohio Northern University.
- Continued receiving contact tracing assistance from PCG through ODH.
