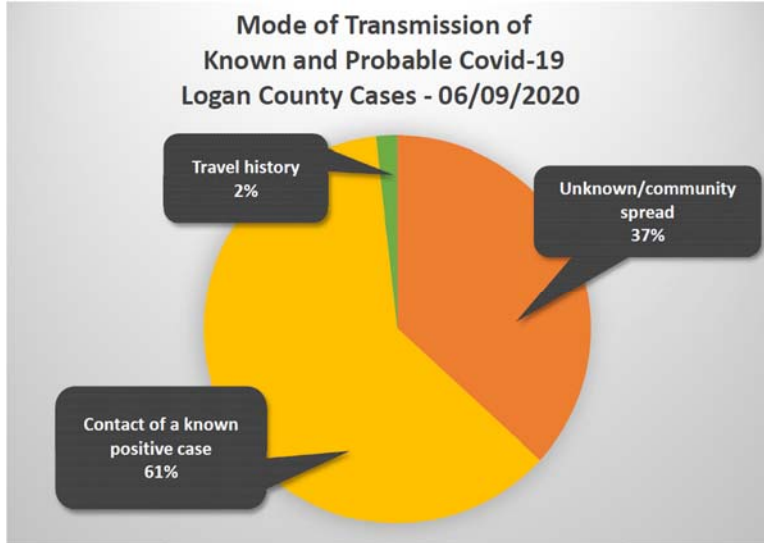


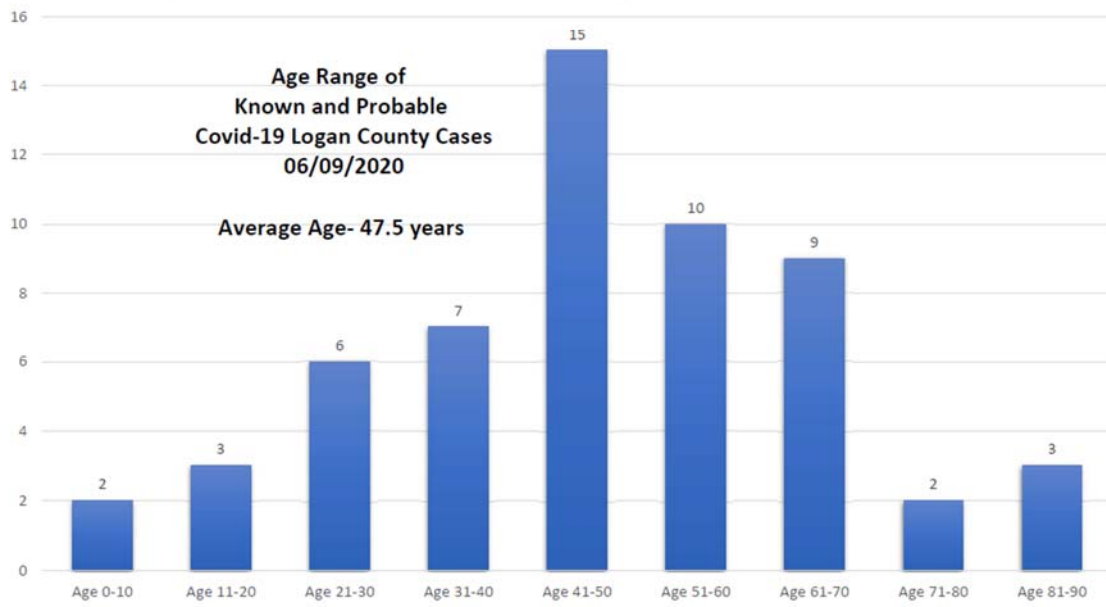
COVID-19 Situational Report The Information in this report is from: 06/01/20 – 06/08/20

ACTIONS COMPLETED SINCE LAST SITUATIONAL REPORT:

- Grant for contact tracing finalized and hired 2 intermittent employees, interviewing for a 3rd.
- Recognized by Auditor of State in Local Health District Spotlight.
- Tested 34 possible cases at a local manufacturing facility that resulted from a party. Out of the 34 tested 3 were positive, 2 were probable – one from out of county.
- Environmental Staff followed up on complaints about business employees not wearing masks.
- Case investigation and Contact Tracing on 50 individuals this week for a total of 498 since 3/17/2020.
- Emailed a reminder to the EMS to use proper PPE on all responses: N-95 Masks, Gowns, Gloves and face shield or goggles.
- Shared a link with the Dentists in Logan County for Wednesday, June 3 @ 2:00-3:00 PM EST ---CDC offered

guidance on non-emergent dental care and optimizing PPE during the COVID-19 pandemic.

- Staff are taking the on-line Point Of Dispensing (POD) training.
- Regional Epi Work Group Conference call for RN-case investigators/contact tracers.

LIAISON:

- Unified Command communicated M, W, F. EMA Continues to fulfill PPE requests from the medical/Dental and eyecare community.
- Dr. Hoddinott participated in the Chamber's weekly business reopening group.
- Dr. Hoddinott worked with schools on band camps and local police regarding the Safety event in August.

LOGISTICS:

- Point of Dispensing (POD) planning.
- Planning for receiving new Biological Refrigerators for vaccine.
- Final PPE from the stockpile moved to MRH storage. Confirmed sprinkler system.
- Received 350 Test Kits received to date from ODH, MRH, and OSU; 291 distributed.
- Planning Conference call on Congregate Care Unified Response Team (CCURT) to learn more about COVID-19 testing in nursing facilities pursuant to the public health order.
- Responded to an ODH survey regarding test kit supplies.
- Received additional PPE into the Logan County warehouse/partnering with MRH/Ron Black.
- A complete inventory was taken of the POD trailer.
- For POD Planning-Walkie Talkies were checked and operational.

STATE INFORMATION:

- A Prevalence Study was delayed and will start in about a week, throughout the state by the Ohio Department of Health. Post cards will be sent out to 12,000 Ohioans. This random testing for COVID-19 will be done on 1200 individuals. This study is being done to help study this disease and how it behaves in our population.
