



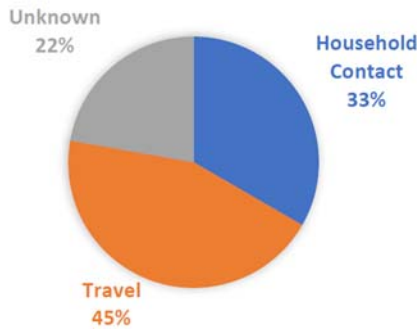

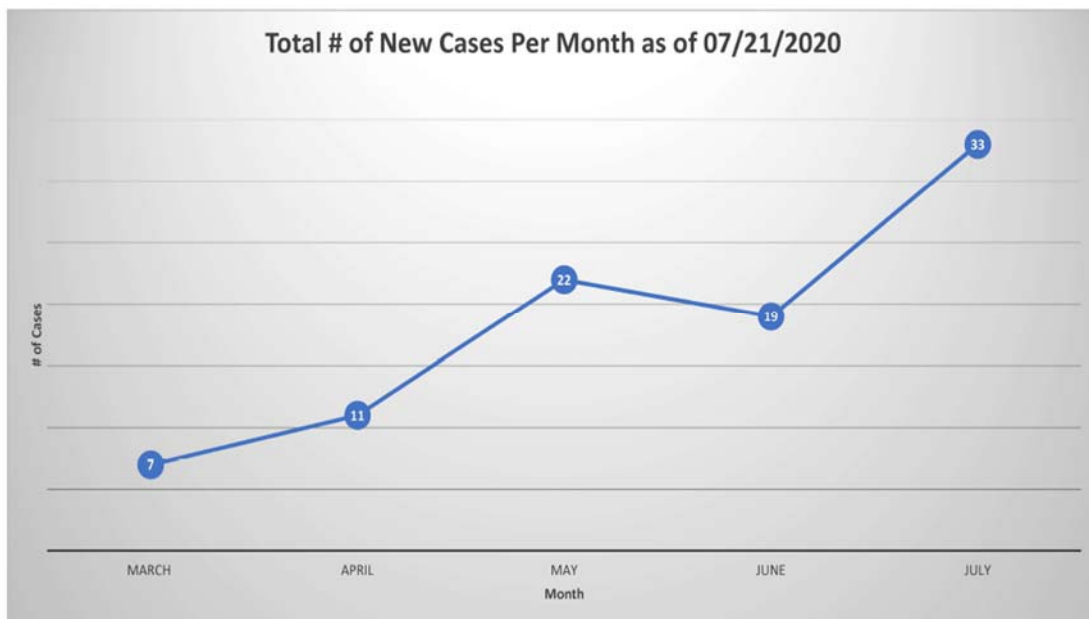
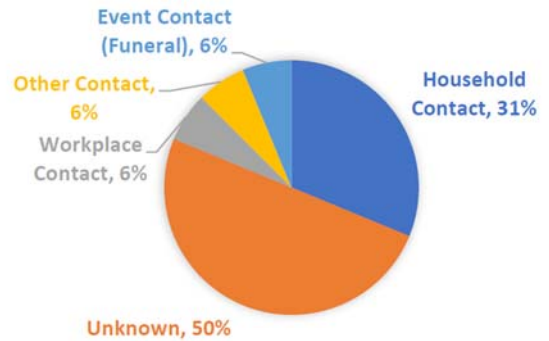
Ohio Cases: 71,592 Total; 76,168 Confirmed; 4,216 Probable;  
Ohio Confirmed Deaths: 2,931

Logan County Cases: 59 confirmed cases plus 32 probable = 91. Of those 91 cases, 58 have recovered. | Deaths: 1 | 32 active cases.

#### ACTIONS COMPLETED SINCE LAST SITUATIONAL REPORT:

- A Health Alert was sent out 7/8/2020. Active cases are increasing in Logan County. The Health Commissioner is very concerned about what he is seeing in the increase of the number of active cases.
- Our public health nurses and contact tracers continue to interview every case of COVID-19 and notify and quarantine all close contacts. We are encouraging all people in the community to wear face coverings. This responsibility is gradually being transferred to the newly hired contact tracers allowing the nursing staff to resume previous duties.
- Environmental staff are conducting complaint investigations of businesses.
- We are providing information and taking complaints at 937-592-9040.
  - If you have a COVID-19 business or mask complaint, enter 3.
  - For nursing COVID-19 calls, enter 1.
- In addition to our COVID-19 efforts and response, we continue to provide programs and services, including Vital Statistics, WIC, TB, food inspections, immunizations (limited), Narcan distribution, newborn visits via phone and CMH program.

#### LIAISON:

- Meetings with school administrators and school nurses to assist in reopening plans. Face shields for teachers are available through the EMA.
- [Testing Resource list](#) sent to HCP's, HCC and the public regarding COVID-19 testing in Logan County
- Requests for PPE are going through the EMA. There are PPE available by calling the EMA at: 937-593-5743
- Unified Command (EMA, MRH & LCHD) continues to meet on a bi-weekly basis.

#### LOGISTICS:

- Received 58 infrared thermometers from ODH.
- Reusable cloth gowns purchased by the Healthcare Coalition were provided to the 3 long term nursing facilities in Logan County.
- 2 New biological refrigerators were received, are being prepared and calibrated for vaccine storage.
- Received quotes for portable refrigerators to be purchased with grant funds. These are needed for COVID-19 Pandemic Response.
- Face shields will be supplied through Logan County EMA for County and BF City schools. EMA has a count of 4000 to fill the need for all teachers & staff.

#### PUBLIC INFORMATION:

- Created testing resource flyer for public requests of where to be tested.
- 12 Social Media Posts with total reach of 28,254
- Situational Report sent to Chamber, Media, Staff, BOH, HCC, HAN
- Call Center: # of calls – over 229 (2 weeks) – large percentage regarding testing.
- CDC changed isolation guidance for most persons with COVID-19 illness, isolation and precautions can generally be discontinued 10 days after symptom onset and resolution of fever for at least 24 hours, without the use of fever-reducing medications, and with improvement of other symptoms.
